# MAYOR'S REPORT: James Wolf

Farmer's Market at Fibonacci will be this Sunday, September 6<sup>th</sup>. There will be a booth set up to Register to Vote. If there is any interest in volunteering to work the polls, please let Mayor know.

There have been several residents with concerns over having the concerts in the park. For the most part people are social distancing. A resident sent in pictures of folks close together without masks. Only have one more concert left on September 4<sup>th</sup>. Does not feel it necessary to cancel the last concert. There is plenty of room at the park to keep social distance.

There have been no decisions made regarding Halloween. We will need to see what Hamilton County decides.

# CITY MANAGER'S REPORT: Bill Kocher

Board of Elections will no longer be using the Community Room as a voting location. There is not enough space for social distancing. They have moved the location to Church of Assumption.

Recently gave the Full Time Police Officer exam. There were 48 candidates signed up to take the test. Had to change the location from Community Room to American Legion to have enough space for social distance. 34 tests were given. Civil Service will be meeting to certify the results.

Zoning Code update. The group just started back meeting in July and another meeting schedule for September 4<sup>th</sup>. The group is Jim Lowenburg, Betty Bollas, Kim Cremeans, Diane Kallmeyer, Dave Osterday. Doing Zoom meetings right now and are making progress. Gone through the entire document. Hoping to have something in the next couple of months as we continue meeting.

Healthcare Connections will have a soft opening on Friday, September 11<sup>th</sup> at 10:00am. They have asked Council members to attend the small event. They will be ready to open the week of September 14<sup>th</sup>.

Road priority projects; Getting ready to apply for state funding. SCIP funding is the most common and a big scoring factor is the condition of the road, which we score high in this area. The big discussion is whether to do a 20% or 30% match.
