# MAYOR'S REPORT: James Wolf

The new rules for Rumpke did pass 2 to 1. The shortened version is that now any new construction, expanded, or newly operated landfill must get approval through the county commissioners, and it also gives them criteria to veto plans. The criteria have to be based on negative impact on either property values, odors, litter, negative impact on recreational activities or to local jurisdictions. This is an update since our last meeting. This will hopefully be a positive impact.

# CITY MANAGER'S REPORT: Bill Kocher

There was an information fact sheet in your packets on Solar. If this interests anybody city manager of Silverton would be happy to come out and speak to council. The Village of Silverton is organizing a program for their residents to learn about solar for their home or business.

Information from Duke. In the near future Duke will be performing gas leak and corrosion inspections in the neighborhood. The inspections are a PHMSA Regulation under the US Department of Transportation (DOT) and necessary for safe natural gas pipeline operations. Duke has arranged for this work to be performed by Southern Cross, Inc.

There was a sheet on the desk of a modification to the attachment to Ordinance 21-1973. We accidently left off the Assistant Fire Chief. He does not fall under the bargaining contract.

Healthy Community Improvement Corporation (CIC). A motion to waive the two-reading rule was made by Mr. Roetting and seconded by Mr. Mueller. A roll call vote carried the motion 6-0. A motion to adopt the ordinance was made by Mr. Parsons and seconded by Mrs. Dosa. A roll call vote carried the motion 6-0.

Ordinance 21-1981 is adopted.

Ordinance 21-1982: A first reading of ordinance authorizing an agreement between the City of Mt. Healthy and the Board of Hamilton County Commissioners relative to the improvement of Hamilton Avenue. A motion to waive the two-reading rule was made by Mr. Roetting and seconded by Mr. Mueller. A roll call vote carried the motion 6-0. A motion to adopt the ordinance was made by Mrs. Dosa and seconded by Mr. Parsons. A roll call vote carried the motion 6-0.

Ordinance 21-1982 is adopted.

Ordinance 21-1983: A first reading of ordinance authorizing the city manager to sign contracts to purchase real property (Hamilton County Auditor Parcel Number 593-0007-0021-00). A motion to waive the two-reading rule was made by Mr. Roetting and seconded by Ms. Moody. A roll call vote carried the motion 6-0. A motion to adopt the ordinance was made by Mr. Parsons and seconded by Mr. Mueller. A roll call vote carried the motion 6-0. Ordinance 21-1983 is adopted.

Ordinance 21-1984: A first reading of ordinance amending the 2021 Appropriations and declaring an emergency. A motion to waive the two-reading rule was made by Mr. Parsons and seconded by Mr. Roetting. A roll call vote carried the motion 6-0. A motion to adopt the ordinance was made by Mr. Mueller and seconded by Mrs. Dosa. A roll call vote carried the motion 6-0.
