

MT. HEALTHY CITY COUNCIL MEETING

May 17, 2022

The council meeting was called to order at 7:00pm by President of Council, Ross Bittner. The invocation was followed by the Pledge of Allegiance.

MINUTES:

A motion to adopt the minutes as printed the May 3, 2022, meeting was made by Mr. Mueller and seconded by Mr. Roetting. An aye vote carried the motion. Minutes were adopted.

GUESTS, SPECIAL EVENTS:

Ed Williams, TEC

Hamilton Avenue Traffic calming study discussion of report. TEC evaluated the Hamilton Avenue corridor and provided recommendation on improvements to benefit the safety and comfort of the corridor. This study focuses on Hamilton Avenue between Kinney Avenue and Adams Road.

TEC observed vehicles in March 2022 traveling in the parking lane throughout the study area. There are many options to take that would have immediate safety impacts with minimal construction impacts.

Council directs Mr. Williams and City manager to move forward with striping using Thermo solid white of parking lane with an edge line indicating the parking spots. Mr. Williams will get a quote for the project to Mr. Kocher and if it is under \$20,000 continue with project. If above \$20,000 council will discuss other options.

Elizabeth Waters,

Owens property in Mt. Healthy. Has thoughts on Food Trucks. Was here last year with her food truck. Has purchased land and had her food truck on the lot on Hamilton Avenue.

This is a unique situation because of the food truck would stay at this same location. Put in parking pad. Would like to be able to park her truck there all the time because she is paying for storage when the truck is not being used. Only using the truck during spring and summer and would like to be able to keep the truck parked there.

In a residential area you cannot take a vacant lot and put just a garage and not a dwelling. That lot could be considered commercial. Has been told a building needs to be there in order to keep the truck there.

Mr. Kocher asks her to write a proposal and we can all look at it and see what the code says. That way all the details will be clear, and we can all get on the same page.

This is not a food truck issue. This is a building code issue with an accessory structure in a commercial area that is not allowed.

- Meal box service ended May 16th

MAYOR'S REPORT: James Wolf

The next Farmer's Market at Fibonacci will be Sunday, June 5th from Noon-3pm. Fibonacci will also be starting up again the Community Meet Up. This will be the 3rd Thursday of the month 6-8pm. This is a terrific way to hear about different groups in the community. A great time to meet your neighbors.

The yard beautification awards were recommended to WeThrive. The proposal is to have 5 different yards recognized each month. WeThrive approved \$300 start up, which will go to buy yard signs to put in each category winner's yard. We can put something about this on our website.

Categories; best manicured, best nature scape, best pollinators, simply perfect, and best food (fruit trees)

Hamilton County Public Health picked us to receive a \$20,000 grant. We are 1 of 2 communities that received this grant if we chose. We are going to run this grant through WeThrive. This is specifically through Ohio Department of Healthy to look at current infrastructure and needs for non-car transportation such as walking, biking, public transportation and come up with a plan on how to improve these areas. There would be a second round of funding to come out and help implement the plan. Similar to Safe Routes to School. Since we are a WeThrive community they will do all the paperwork for us.

The old Rink's building in Springfield Township will be torn down and turned into a self-storage facility

Mr. Kocher and I will be meeting with College Hill Community Urban Redevelopment Corporation next week. Looking to see if there is any possibility of teaming up.

The update on ambulance. Right now, the wait is on a chip. Looking like around July 18th before the chip is received. It will be 6 weeks once the chip is received

May 28th is the plan to open the pool for the 2022 season


