**AN ORDINANCE TO SET COMPENSATION FOR CERTAIN APPOINTED
OFFICIALS AND PART TIME EMPLOYEES OF THE CITY OF MT. HEALTHY**

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MT.
HEALTHY, STATE OF OHIO:

Section 1. That the compensation for certain appointed officials of the City of Mt.
Healthy beginning January 1, 2020 shall be as set out in Exhibit A, hereof.

Section 2. This ordinance shall be in full force and effect from and after the first day
permitted by law.


