AN ORDINANCE AUTHORIZING THE CITY MANANGER TO EXECUTE AN AGREEMENT BETWEEN THE CITY OF MT. HEALTHY AND RUMPKE FOR COLLECTION, TRANSPORTATION AND DELIVERY FOR DISPOSAL OR PROCESSING OF SOLID WASTE AND RECYCLABLE MATERIALS GENERATED IN AND COLLECTED FROM RESIDENTIAL UNITS, RESIDENTIAL UNIT EQUIVALENTS, MUNICIPAL FACILITIES AND DURING SPECIAL EVENTS

**WHEREAS,** The City of Mt. Healthy's household waste and recycle collection contract with Rumpke will expire on March 31, 2016, and

**WHEREAS,** The City has joined the 2015 Southwest Ohio Regional Refuse Consortium that includes the Cities of Loveland and Springdale and the Villages of Fairfax and Greenhills in an effort to obtain the best possible bid.

**NOW THEREFORE,** BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

- **Section 1.** That the City Manager is hereby authorized to sign an agreement accepting the bid from Rumpke as presented by the consortium in the attached Exhibit A, between the City of Mt. Healthy and Rumpke of Ohio, Inc.
- **Section 2.** That the term of the agreement is for 5 (five) years at a fixed rate of \$40.95 per quarter year per residential unit or residential unit equivalent.
- **Section 3.** That, in addition to the quarterly household waste and recycling rate there will be a \$7.15 per quarter year service charge per residential unit or residential unit equivalent to cover the billing and servicing costs incurred.
- **Section 4.** That, the agreement and total price of \$48.10 per quarter year, per residential unit or residential unit equivalent will go into effect on April 1, 2016.

**Section 5.** That, the current scheduled pick-up days will remain unchanged.

**Section 6.** That this Ordinance shall be in full force and effect from and after the first date provided by law.
