AN ORDINANCE REAPPOINTING MEMBERS TO THE SPRINGFIELD TOWNSHIP JOINT ECONOMIC DEVELOPMENT ZONE I BOARD OF DIRECTORS AND DECLARING AN EMERGENCY

WHEREAS, the JEDZ I Contract and Section 715.691(G)(1) of the Ohio Revised Code provide for the creation of a board of directors to govern the activities and business of the JEDZ;

WHEREAS, the JEDZ I Contract and Section 715.691(G)(1) of the Ohio Revised Code provide that there shall be six (6) members of the JEDZ Board, and that three (3) members shall be appointed by each Contracting Party; and

WHEREAS, on June 17, 2014 the Council of the City of Mt. Healthy passed Ordinance No. 14-1706 appointing the following three (3) persons to become members of the JEDZ I Board of Directors:

William Kocher Bob Parsons Ray Rissel

WHEREAS, the City of Mt. Healthy Ordinance No. 16-1788, Section 3, provides that:

Section 3, The aforementioned members may be reappointed to the Board of Directors for successive terms at the sole discretion of the Council of the City of Mt. Healthy.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

Section 1. The City Council of the City of Mt. Healthy hereby reappoints the following three (3) persons to continue as members of the JEDZ I Board of Directors:

William Kocher Bob Parsons Ray Rissel

- **Section 2.** Each member shall serve on the Board of Directors for two (2) years, from August 16, 2018 until August 16, 2020.
- **Section 3.** The aforementioned members may be reappointed to the Board of Directors for successive terms at the sole discretion of the Council of the City of Mt. Healthy.
- **Section 4.** This ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, healthy, and safety of the City of Mt. Healthy and its inhabitants. The reason for the emergency is to ensure compliance with the timelines established in the JEDZ I Contract. Therefore, this ordinance shall become effective upon its passage.
