## AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ESTABLISH TERMS AND CONDITIONS FOR THE SAFE PRESENTATION OF THE CHURCH OF ASSUMPTION FESTIVAL

**WHEREAS,** the Church of the Assumption will present their annual festival on the Church's property in Mt. Healthy on Friday June 7<sup>th</sup> from 6:00 pm to 11:00 pm, Saturday June 8<sup>th</sup> from 5:00 pm to 11:00 pm, and Sunday June 9<sup>th</sup> from 1:00 pm to 9:00 pm,

**WHEREAS,** a Safety Plan has been made by the Church of the Assumption and given to the City of Mt. Healthy for review and consideration,

**WHEREAS,** it is the desire of the Council of the City of Mt. Healthy to adopt certain recommendations of this Safety Plan to create a safe environment for the patrons and residents in and around this event.

**NOW THEREFORE,** BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

**Section 1.** That the City Manager is authorized to establish terms and conditions for the use of the festival area and adjacent areas as shown on the attached map. See Attachment A.

**Section 2.** That the City Manager is authorized to take such actions as are in his opinion necessary for the safe presentation of the Assumption Festival by the Church of the Assumption, notwithstanding any provisions of the Mt. Healthy Municipal Code, including but not limited to Chapter 132 Sections 25, 26, 27, 28, 32, and 33.

**Section 3.** The City of Mt. Healthy will enact and enforce a Curfew of 9:00 pm for juveniles 16 years of age or younger not with a parent or legal guardian, and 10:00 pm for 18 years of age or younger not with a parent or legal guardian with the exception of going

to or from the event. Said curfew shall apply to the area within the City outlined in red on Attachment A, attached hereto.

**Section 4.** The City of Mt. Healthy will provide Event Monitors in a number to be determined by the City Manager at dusk for each evening of the event that includes both male and female members with standardized T-shirts indicating their role/identity. Monitors from Assumption Church will be paired with Monitors from Overflow Ministries Covenant Church each undergoing proper training.

**Section 5.** That this Ordinance shall be in full force and effect from and after the first date provided by law.
