ORDINANCE NO. 19-1885

**AN ORDINANCE ESTABLISHING SECTION 76.19 OF THE MT. HEALTHY OHIO CODE OF ORDINANCES**

**WHEREAS**, the Street Committee has identified the need to establish a section of the Mt. Healthy Code of Ordinances regarding parking in a certain city owned alleyway going east/west between Hamilton Ave. and Harrison Ave..

**NOW THEREFORE**, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

**Section 1.** That Section 76.19 shall be established and become part of the Code of Ordinances of Mt. Healthy, Ohio and shall read as follows:

**Section 76.19 ALLOWING PARKING IN A CERTAIN CITY OWNED ALLEYWAY.**

- (A) Except as otherwise provided, parking shall be allowed in the alleyway that runs from Harrison Ave. east to the north/south alleyway that runs between Compton Rd. and Kinney Ave.; that borders on the city owned parking lot just south of the property at 7516 Harrison Ave. and allowing access to the property located at 7508 Harrison Ave.
- (B) Parking regulations in this area shall be the same as if it were a city owned parking lot, or as otherwise directed by the City.

**Section 2.** That this Ordinance shall be in full force and effect from and after the first date provided by law.
