RESOLUTION NO. 19-1130

A RESOLUTION TO DISBURSE REVENUES FROM THE CITY
TO THE HILLTOP JOINT FIRE AND RESCUE DISTRICT

Whereas, the City of Mt. Healthy has proposed the creation of a joint fire district with the City of North College Hill called the Hilltop Joint Fire and Rescue District ("the District"); and

Whereas, the Mt. Healthy City Council voted to approve the creation of the District with the City of North College Hill on February 5, 2019 (Resolution 19-1126); and

Whereas, the City of North College Hill City Council voted to approve the creation of a the District with the City of Mt. Healthy on February 19, 2019 (Resolution 1-2019); and

Whereas, the agreement between the City of Mt. Healthy and the City of North College Hill to create the District requires that the City of Mt. Healthy disburse \$10,000.00 as "seed" money for the newly created Hilltop Joint Fire and Rescue District.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO

Section 1. That revenues from the City of Mt. Healthy in the amount of \$10,000.00 are to be disbursed to the Hilltop Joint Fire and Rescue District.

Section 2. That this Ordinance shall be in full force and effect from and after the first date provided by law.


