Has own sound system, his events usually bring in 200-300 people. Request approved, City Manager directed Mr. Williams to fill out an event permit form. Debbie Lackey, 7615 Joseph Street / Decrepit Roads/Alleys

Continued concerns about alley, business parking, and neighbor parking. Exchange with City Manager inaudible. No public funds available for alleys. Council member recommended she talk with her State legislator.

Jasmine Ramsey, 1289 Landis Lane / Mt. Healthy High School Cheerleading
Mt. Healthy 2010 alumnae. Requesting sponsorship for mini cheerleading camp for 5-12
year olds, needs donation of \$800. Cost of camp is \$20 for Mt. Healthy residents, \$30 for
non-residents. Wants to rebuild the cheer culture at Mt. Healthy High School. Hoping to
give 50 young athletes an opportunity to attend the camp. Mrs. Dosa asked whether

CITY MANAGER'S REPORT: Scott Bauer

- ➤ Distributed Resolution for Liquor License Objection We are withdrawing objection, Mr. Oliver has agreed to sign the agreement attached to Resolution. May 11th hearing date.
- ➤ UDF Update Traffic counter at opening on Adams. 161 cars/day, as high as 214. After speed bump, dropped to less than 100/day, significant decrease in number of cars going through the alley. Mr. and Mrs. Sterwerf comments barely audible, speed bumps in alley are affecting UDF customers, not the drivers who speed through. Would be helpful to have police stop a few drivers, give citations, word will get out.
- SORTA Legislation Does not have it for this meeting, is due June 15. Timing okay as long as it is passed at May 16th meeting.
- > Fire Truck Grants are being issued, no way of knowing where Mt. Healthy is in the process.
- > Public Works Seasonal employee starts on Monday. Will help with filling potholes.
- Compton Road Update Mill off top, put on intermediate layer, full depth repairs and then final coat. Much is weather dependent, hoping for completion in next few weeks.

POLICE DEPARTMENT REPORT: Chief Jerry Deidesheimer

- > Chief Demasi left the police department in really good shape, extremely impressed.
- > Citizens Use of Force Review Urban League observed, wants to use Mt. Healthy as framework for all other municipalities in Hamilton County.
- Parking Issues 12 cars towed, several vehicles moved. Sergeant Fath drafted a letter and, along with Ordinance, put on trucks in City lots. Some moved, Sgt. Fath working with other owners in getting them moved.
- ➤ Personnel Open spot for one Sergeant position, assessment on May 13th, three officers applied for this promotion. Conditional offer to Christine Nared, offer accepted, hoping to get her on board mid to end of May.
- With school ending, officers can devote more time to traffic enforcement, including violations in alley on Joseph Street.
- Open House on May 18th, agenda complete.
- Met with schools several times over safety issues, cooperative effort working with superintendent and others over matters to give police heads up on things that may cross over from school to law enforcement.
- Personnel Looking at other scheduling options, different hours.
- Pleasure working with these officers. Squared away, dedicated, smart officers working here in Mt. Healthy.
