MT. HEALTHY CITY COUNCIL MEETING July 18, 2023

Public meeting of the Mt. Healthy CRA Housing Council was held prior to the council meeting.

The council meeting was called to order at 7:02 p.m. by President of Council Ross Bittner, followed by the invocation and Pledge of Allegiance.

MINUTES:

A motion to adopt the June 20, 2023 minutes as printed was made by Mr. Roetting and seconded by Mr. Parsons. An aye vote carried the motion 7-0. Minutes adopted.

PUBLIC INPUT:

- Mara Harperink Member of Historical Society and Business Alliance. Museum's annual fundraiser on August 5th during yard sale. Need donations and help setting up and tearing down. Sales from Mt. Health-opol-y game will bring annual fundraising for Museum from \$2,000 to \$15,000. Contact Mara with any questions. Hoping to finalize by early August and have before Black Friday. / Adams Road resident. Any way to get speed humps on Adams? At least two deer get hit annually and have to be disposed of by police, she was almost hit the other day, multiple car accidents with one car ending up in the ditch across the street from her, and cars use the road for racing at night. City Manager will have put our traffic counter placed on that section of Adams.
- Aaron Horsley Overview of Forest Avenue Renewal project handout. Items purchased from HEEL grant include water tank for watering trees that were planted, projects for trail marking to give people a sense of direction (Krissy Hollbrook, resident and local painter, volunteered to paint those signs), and bat boxes installed. Also, trail signs, information sign (similar to one in Heritage Park an information hub), and continuing care of trees. Volunteer Appreciation Picnic in the Fall, flyers at next council meeting.
- Dwight Weese Tree Commission update. The Commission has narrowed items down from eight to three, working now on budget, trying to get quotes and input from professionals in the area. First item is to address is the hazard reduction of trees in community, second is to implement a more onward going yearly plan to remove and prune tree canopies lining the streets, third is to plant new trees, which includes soil remediation. Trying to pull in partnering capability with Public Works. They could do quite a bit of that work and hours could be leveraged into calculations for 50/50 split; not asking for straight money but the labor as well. Will have proposal at August council meeting. Annual grant, would run for four years.

Jim Lowenberg - Energy Harbour not willing to budge on net metering. If you are using solar energy for net metering you can not be part of the energy aggregation. Not much we can do at this point, when contract is up encourages city to insist net metering residents be allowed to enroll in aggregation. Has never been an issue with any other aggregation we have had, Energy Harbour relatively new. Not regulated by PUCO, so energy companies can do whatever they want. City's consultant should have been on top of this.

Discussion topics included the summer concert series, bringing back park events such as movie night (tentative August 12th, working with Public Works to make sure equipment works) and yoga in the park. Also working on playground equipment and grants. Looking for volunteer to help with grants.

<u>Streets Committee: Peggy Rissel</u> No report. Has reached out to police chief regarding disabled cars on the street and they are taken care of quickly.

MAYOR'S REPORT: James Wolf

- Community development block grant, at end of cycle, started in 2020. The mayor, Paul Young, M/M Feldman and 3CMH (3rd Century Mt. Healthy), met with Hamilton County planning, have clear definition of what needs to be done and have time to do it. CURC working on facade improvement and identified future businesses that can use the help. Getting plan together for street scape. Will have to start thinking about next three years of funding, keep on radar. How do we want to spend that amount of funding from the county?
- > 3CMH working out of City Hall 1-2 days/week, facilitates good communication.

- CRA Housing Council Mayor Wolf, Mr. Bittner and Mr. Roetting are on that council, Jenny Moody agreed to be on board, Mayor officially appointed her; need one more Clovernook resident appointment. Mayor Wolf can stay on the board when he is no longer Mayor since he was appointed by the Planning Commission.
- Money flowing from Hamilton County Public Health lately, money for Tree Commission and backpack grant. Hamilton County received \$10k HEEL grant in our name, hired a firm to conduct Mt. Healthy resident surveys; grant also paid for \$25 Kroger gift cards to give to residents who participated in survey. Result of surveys largely focused on park and need for playground equipment. Since it was identified by residents, sets us up for additional funding. Mayor to call Nicole Key (Hamilton County Public Health), will be in touch with Kisha. Amount of new grant unknown at this time.
- Community Picnic \$3,500 check received from Hamilton County to be used for school supply drive and other drives for lower income areas. Emmanuel Temple and Trinity will hold the event on August 5 from 2-5 p.m.
- CVS Alot of residents are asking about CVS closing. Confirmed that back parking lot belongs to the city.
- ➤ Hamilton County Commissioners here August 10, Commission on Women and Girls; using council chambers 5-8 pm then reception at Fibonacci. County will be providing everything, including Hamilton County Sheriff detail. We are providing the space.

CITY MANAGER'S REPORT: Scott Bauer

- CVS Closing on August 2nd. Sent letter to corporate asking for information on intent for building.
- Yoga Working on six week trial of Yoga in the Park, fine-tuning contract. Will be offered on Monday nights at no cost and on Wednesday night at \$10/person (all \$ goes to instructor). Will start up next week.
- > Fire Department promoted three fire captains.
- Police Christina Nared and Joe Robers doing great. Brad Williams gave two week notice. This gives us two open spots plus detective position which will open up soon.
- > July 3 First one he has attended, went well. Good reports from police department. Mr. Parsons commented it was the best one he's ever seen in Mt. Healthy.
- Clovernook Meeting with CEO of PURL, Hamilton County, and one of the police sergeants tomorrow.
- ➤ West side of Compton finished. Forest-Madison sewer and water repairs will be done this year, road will be done in 2024.

- Congratulations to Emily Jeffries, who passed paramedic test back in May, she is now one of our career medics.
- One career firefighter left for another department, we picked up a candidate who was on our list (Michael Horton); started on July 11th. Starting medic school very soon, will be graduating in August 2024. Other two in medic school graduating this year.
