## Dawn Walter, 7340 Elizabeth Street / Penalty for Tree Removal

Concerned about the misdemeanor charge and \$500 penalty for removing a tree put in the right of way without homeowner's permission; specifically, one of her rental properties where member of Urban Tree Commission got permission from the renter, not the owner of the property. Owner wants trees removed. Response: Since Ordinance was passed as non-emergency, will check with City Law Director to see if still inside 30-day window; if so, owner can remove trees without penalty. Will get back to Mrs. Walter after speaking with Law Director.

# FIRE DEPARTMENT REPORT: Chief Steve Lawson

- > July-September: 461 EMS runs, 42 fire runs
- Did not get assistance firefighter grant for pumper. Still in process for SAFER grant (two career firefighters).

Fire Inspections - 55 so far this year. 219 businesses, but not all are occupied. When there are violations, some are minor. Fire Department works with business owner on others. No occupancy rate issues since Stadium Bar & Grille changed their name and business model. Police and Fire working together if complaint is made for overcrowding.
