The homicide that took place at Clovernook Apartments was solved. Marice Lamar was arrested and charged with first degree murder. Lamar and the victim were known to each other. Mt. Healthy Police worked closely with the Hamilton County Investigative Unit and the Fugitive Task Force to investigate the case and capture Lamar. Clovernook Apartment Management were cooperative as well. There is still a concern regarding their camera system not being fully operational.

An eviction notice was issued to the residents at 7426 Werner Avenue. The address has been the source of several calls for service and criminal activity. We were pursuing the possibility to declare the residence as a nuisance. However, after working with the owner, they agreed to move for eviction.

We had 275 traffic contacts for April resulting in 215 citations. To address the community concerns for speeding and traffic violation, additional shifts were authorized to perform targeted traffic enforcement during afternoon rush hour traffic.

Court revenue is up 10% from this time last year. This is a result of working with the prosecutor to ensure traffic citations written for Driving Under Suspension are accompanied by the citations for the initial traffic stop. The Mayor's Court Admin continues to work with an outside collection agency to track down and collect delinquent fines.

We assisted the Mt. Healthy Preparatory Academy with an evacuation drill. Pastr Washington also participated in providing a reunification location in the event of a critical incident.
