Mt. Healthy Police had 168 traffic contacts for the month of February resulting in 127 traffic citations. The number of traffic accidents also increased. There was also a focus on parking violations and junk vehicles. Mt. Healthy Police will continue to focus on traffic enforcement and parking throughout the year. With the assistance of the Hamilton County OVI Task Force, we are planning an OVI Checkpoint on Hamilton Ave. for March.

Gametime Bar (We Do Barbeque) was cited by Ohio Liquor Control, and they no longer have a liquor license. We met with the owner of Reminisce Bar (MUL) regarding hours of operation. They have been provided with a copy of the City Ordinance and have been cooperative.

We continue to work with the management company at Clovernook Apartments. They have been successful in following through with evictions, however, calls for service continue. The camera system at Clovernook Apartments is unreliable at best. A meeting will be held to discuss how we can cooperate and provide assistance.

The renovations in the Police Department continue. All work is being completed by the Public Works Department.
