AN ORDINANCE AMENDING CHAPTER 77, SCHEDULE 1 (TRAFFIC AND PARKING) OF THE MT. HEALTHY CODE OF ORDINANCES

WHEREAS, In order to maximize parking for customers of the businesses in the Core Business District certain modifications to time limits for parking have become necessary.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

Section 1. That Chapter 77: Traffic and Parking, Schedule I (A), Parking Time Limited or Prohibited, of the Mt. Healthy Code of Ordinances is hereby amended to include:

- A) 1 Hour parking limit from 7:00AM to 5:00PM on both sides of Hamilton Ave. from Stevens Ave. to McMakin St.
- B) 1 Hour parking limit from 7:00AM to 5:00PM on both sides of Compton Rd. from Hamilton Ave. to a point 151 feet east ending at the alleyway.
- C) 1 Hour parking limit from 7:00AM to 5:00PM on both sides of Compton Rd. from Hamilton Ave. to a point 154 feet west ending at the alleyway.

As noted below in Schedule 1.
