ORDINANCE NO. 23-2019

AN ORDINANCE ASSESSING COSTS OF THE REMOVAL OF LITTER, RUBBISH AND GARBAGE AND DECLARING AN EMERGENCY

WHEREAS, Sections 95.61-95.64 and 153.31 of the Codified Ordinances authorizes the city to cause any litter, rubbish and garbage to be removed from any property located within the city when the owner of the property fails to cause such litter, rubbish and garbage to be removed; and

WHEREAS, Sections 95.61-95.64 and 153.31 of the Codified Ordinances authorizes the city to charge the costs of removing litter, rubbish and garbage to the property owner or owners; and

WHEREAS, Sections 95.61-95.64 of the Codified Ordinances further authorizes the city to certify to the county auditor the costs of removing litter, rubbish and garbage for collection as other taxes and assessments are collected when the property owner or owners have failed to pay the charges after due notification from the city; and

WHEREAS, the city has caused litter, rubbish and garbage to be removed from several properties in the city and the owner or owners have refused to pay the costs thereof after having received due notification from the city;

NOW THEREFORE, BE IT ORDAINED, by the Council of the City of Mt. Healthy, State of Ohio, two-thirds of the members elected thereto concurring:

Section 1. The following amounts have been charged to the properties listed below for costs incurred by the city in removing litter, rubbish and garbage:

Section 2. The amounts listed in Section 1 above shall be certified to the County Auditor for collection as other taxes and assessments are collected.

Section 3. The clerk is hereby authorized to certify a copy of this ordinance to the Hamilton County Auditor.

Section 4. This ordinance is declared an emergency measure for the immediate preservation of the public peace, health and safety. The reason for the emergency is that immediate passage is necessary to meet the county's filing deadline for placing the amounts on the tax rolls for next year. This ordinance shall take effect and be in force immediately upon its passage by Council and approval by the Mayor.
