A RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR

Rev. Code, § 5705.34

WHEREAS, this Council, in accordance with the provisions of law, previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1, 2024; and

WHEREAS, the Budget Commission of Hamilton County, Ohio, has certified its action thereon to this Council, together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council, and what part thereof is without and what part within the ten mill limitations;

NOW, THEREFORE, BE IT RESOLVED, BY THE COUNCIL OF THE CITY OF MT. HEALTHY, HAMILTON COUNTY, OHIO:

Section 1. That the amounts and rates as determined by the Budget Commission in its certification be and the same are hereby accepted; and be it further resolved

Section 2. That there be and is hereby levied on the tax duplicate of said City the rate of each tax necessary to be levied within and without the ten mill limitation as follows in Schedule A; and be it further resolved

Section 3. That the Clerk of this Council be and is hereby directed to certify a copy of the Resolution to the County Auditor of Hamilton County.
