ORDINANCE NO. 21-1968

**AN ORDINANCE ACCEPTING PLAT OF PUBLIC STORM SEWER EASEMENT
FOR SEWER PURPOSES LOCATED NEAR THE ADDRESSES RANGING WITHIN
7941-8005 ON ELIZABETH STREET**

WHEREAS, the City Engineer for the City of Mt. Healthy and the property owners of addresses 7941, 7952, 7955, 8000, 8001, and 8005 on Elizabeth Street in the City of Mt. Healthy have requested that the plat of public storm sewer easement for storm purposes be accepted by the Council of the City of Mt. Healthy, and

WHEREAS, this plat was approved by the City Engineer for the City of Mt. Healthy, and;

WHEREAS, the Ohio Revised Codes Section 711.08 states no plat shall be recorded until it has been approved by the legislative authority of the municipal corporation, and;

WHEREAS, the Council of the City of Mt. Healthy has evaluated the utility of accepting the above-referenced plat of public storm sewer easement for storm purposes and concluded that such acceptance would be in the best interest of the City.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

Section 1. That the Council of the City of Mt. Healthy accepts the above-referenced plat of public storm sewer easement for storm purposes located near the addresses ranging within 7941-8005 Elizabeth Street and authorizes the City Manager and/or his designee to execute and/or record any documents and the above-referenced plat to confirm such acceptance.



That Council finds and determines that all formal actions relative to the passage of this Ordinance were taken in an open meeting and that all deliberations of Council which resulted in the passage of this Ordinance were taken in meetings open to the public, in full compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section 3. That this Ordinance shall be in full force and effect from and after the first date provided by law.

Passed this 16 day of November, 2021.


