ORDINANCE NO. 22-1986

AN ORDINANCE ESTABLISHING A CERTAIN RATE OF PAY FOR THE NEW CITY MANAGER OF THE CITY OF MT. HEALTHY

WHEREAS, the current City Manager, Bill Kocher, will serve and be compensated until retiring his position effective July 31, 2022; and

WHEREAS, the new incoming City Manager, Scott Bauer, will be starting July 1, 2022, and be compensated in the manner as set forth below with a short overlapping stint where both will be compensated for the month of July 2022.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

Section 1. The new incoming City Manager will receive an annual salary of \$120,000.00 (One hundred and twenty thousand dollars) paid evenly throughout every two weeks in a bi-weekly manner along with 4 (four) weeks of vacation (20 business days) per year and seventy-five dollars (\$75.00) per month in cell phone reimbursement.


Section 2. That the City Council by a ¾ majority vote hereby dispenses with the requirement that the Ordinance be read on two separate days and hereby authorizes the adoption of the Ordinance upon its first reading. That this Ordinance is an emergency and shall take effect and be in force from the earliest date allowed by law.

Section 3. That Council finds and determines that all formal actions relative to the passage of this Ordinance were taken in an open meeting and that all deliberations of Council which resulted in the passage of this Ordinance were taken in meetings open to the public, in full compliance with all legal requirements including Section 121.22 of the Ohio Revised Code. That this Resolution shall be in full force and effect from and after the first date provided by law.


