**RESOLUTION NO. 21-1156**

**A RESOLUTION REQUESTING THE COUNTY AUDITOR TO MAKE PAYMENTS OF TAXES PURSUANT TO OHIO REVISED CODE§ 321.34**

**WHEREAS**, the Ohio Revised Code allows a taxing authority to request payment from the County Auditor funds derived from taxes or other sources to the County Treasurer, which may be held on account of a local subdivision;

**NOW THEREFORE**, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

**Section 1.** That the Auditor and the Treasurer of Hamilton County in accordance with Ohio Revised Code § 321.34, be requested to draw and pay to the City of Mt. Healthy upon the written request of Scott Bauer, Finance Director, to the County Auditor, funds due in any settlement in 2020 derived from taxes or other sources, payable to the County Treasurer to the account of the City of Mt. Healthy, and lawfully applicable for purposes of the current fiscal year, 2021.

**Section 2.** That the Clerk of the City of Mt. Healthy shall forward to the County Auditor a certified copy of this Resolution.

**Section 3.** That this Resolution shall be in full force and effect from and after the first date provided by law.
