RESOLUTION NO. 21-1162

A RESOLUTION OPPOSING THE RENEWAL OF THE OHIO DEPARTMENT OF LIQUOR CONTROL LICENSE FOR THE BUSINESS LOCATED AT 7701 HAMILTON AVENUE DBA VINCE'S OTHER PLACE, FIRST FLOOR, BASEMENT, AND PATIO OWNED BY 7701 HAMILTON AVE LLC, AND DECLARING AN EMERGENCY

WHEREAS, the Mt. Healthy Police Department has received numerous calls and responded numerous times to complaints of disorder and illegal conduct being conducted by patrons of this establishment as detailed in the attached listing compiled by the Mt. Healthy Police Department attached hereto as Exhibit "A"; and

WHEREAS, these complaints include, but are not limited to, robberies of patrons, fights, assaults, thefts, drug violations, wanted individuals, noise complaints, and/or suspicious activity, taking place on and/or near the premises; and

WHEREAS, such consistent conduct has continuously caused panic and alarm to members of our community and continuously created a disruption of the peace and tranquility in the City of Mt. Healthy.

NOW THEREFORE, BE IT RESOLVED BY A MAJORITY OF THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

Section 1. The City of Mt. Healthy hereby opposes the renewal of a liquor license to the business at 7701 Hamilton Avenue DBA Vince's Other Place, 7701 Hamilton Ave LLC, owner.


Section 3. That Council finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting and that all deliberations of Council which resulted in the passage of this Resolution were taken in meetings open to the public, in full compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section 4. This Resolution is declared an emergency measure for the immediate preservation of the public peace, health, safety and general welfare of the people of the City of Mt. Healthy. The reason for the emergency is that immediate passage is necessary to present opposition to the renewal of the Ohio Department of Liquor Control permit for the premises in question. That the City by at least a vote of three fourths of its members hereby dispenses with the two-reading requirement of the Charter that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading. This Resolution shall take effect and be in force immediately upon its passage by Council and approval by the Mayor.



Subject: 2021 Liquor Renewal Objection Vince's Other Place

As you are aware only the local legislative authority can object to an annual liquor permit renewal by taking the following actions:

- Adopt a resolution stating the reason for the objection and forward a copy to the State of Ohio Department of Commerce, Division of Liquor Control, no later than 30 days before the expiration date of the permit.
- Provide a statement to accompany the resolution from the chief legal officer stating that they have reviewed the resolution, and in their opinion, it is based on substantial legal grounds.

The grounds for which the Division can deny a permit or reject a permit renewal are provided in Ohio Revised Code Section 4303.292. This documentation must be submitted to the Ohio Department of Commerce, Division of Liquor Control, before June 1, 2021.

The Mount Healthy Police Department would request consideration for such ordinance, passed by Mount Healthy City Council, objecting to the renewal of the following liquor permit premise:

Vince's Other Place - 7701 Hamilton Avenue

In evidence thereof, since January 1, 2018, Officers have been called to this location 52 times for various situations including, robberies of patrons, fights, assaults, thefts, drug violations, wanted individuals, noise complaints, and suspicious activity.

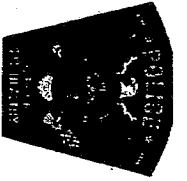
Attempts to meet with ownership have not been successful in resolving the issues occurring at this liquor establishment. The Ohio Department of Liquor Control has been notified by Mount Healthy Police of the various activities occurring at this location. They have responded to investigate and issued citations to the ownership and offered training to their employees.

Despite our efforts to resolve the criminality occurring at this liquor establishment, illegal activity continues to occur. This location substantially and adversely is interfering with the public decency, sobriety, peace, and good order of the neighborhood, and or the normal, orderly conduct of a public institution.

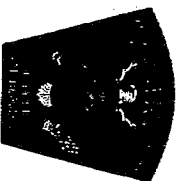
I therefore recommend City Council issue a formal objection to the renewal or issuance of a liquor permit for this establishment.
